



Invocation of law

Through our collective will and rightful dominion over land, air, and sea, we invoke the supreme and natural authority that is our inherent birthright. Let it be clearly affirmed—in our status-corrected capacity as the lawful possessors of the land and soil of Terra Australis, by our will, our right, and our duty, in behalf of all men and women, we invoke the protection of Law, to the benefit of all who live.

Principles of law

All are subject first to the immutable Natural Law.

In the Land and Soil jurisdiction on Terra Australis, the Law stands as the supreme and unalienable Law of the Land and Soil jurisdiction, timeless, self-evident, and universally applicable. The guiding principles of this Law are as follows:

1. Do no harm.
2. Cause no loss.
3. Honour all agreements and commitments.
4. Keep the peace.
5. Be a good steward of the land and shared resources

These principles uphold the sacred balance between individual free will, responsibility to one's fellow man and the unwritten nature of the Law in this jurisdiction.

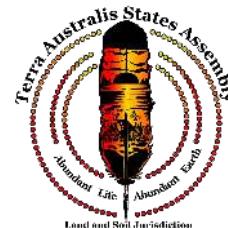

Guiding tenets of our law

We further affirm the following tenets which ensure self-governance assemblies remain subject to the **collective will of the people** and the Law of Terra Australis:

- **Self-Governance** - Every man and woman is accountable for the outcomes of their actions, and have a responsibility to protect each others life, property, and Natural Rights.
- **Subsidiarity** - All decisions are made at the most local, competent level, by those most affected, ensuring governance remains participatory, accountable, and reflective of the people's will.
- **Restorative Justice** - When harm occurs, the primary objective is to restore balance, repair relationships, and uphold accountability in a manner that honours all involved.
- **Direct Jury Trial** - All trials are conducted by juries selected at random from a jury pool of qualified members of the local community. The jury determine the facts, the Law, and the appropriate remedy or consequence. Jury decisions are final and not restricted by any statutory or corporate rules. Local Jural Assembly courts are the highest courts in the jurisdiction of the Land and Soil. A trial jury or grand jury will overturn statutes and decisions by any assembly or corporation if found to cause harm.
- **Plain English Communication** - All matters of Law are expressed in clear, comprehensible English, free from legal jargon, corporate codes, or misleading terminology.
- **Equality Before the Law** - No man or woman stands above the Law. All are both bound and protected equally by its principles.
- **Environmental Stewardship** - The protection and nurturing of land, water, and natural resources is a duty of all men and women, ensuring enjoyment now and abundance for generations to come.



- **Unwritten Law** - True Law is unwritten, living within the conscience and customs of the people. Assemblies may not create rules, statutes or regulations that infringe upon a Natural Right.

These tenets guide our Assemblies, our courts, and our communities, forming the foundation for peace, abundance, and community.

Law and lore: one truth

It is said that Law and Lore are different, yet this distinction arises only when they are written down. In truth, both are expressions of the same timeless principles of right action, fairness, and the accumulated wisdom of mankind, and both are unwritten in nature.

On Terra Australis, we recognise Law and Lore are one and the same—existing to guide and protect life in harmony with nature.

Applicability of law

1. Jurisdiction and Protection:

- All men and women present upon these lands—whether native-born, visiting, or living—are subject to and protected by this Law.
- When harm is caused, it shall be addressed through courts of the Jural Assembly, in a Direct Jury Trial having a primary aim of restoring justice and balance.
- Only declared Terra Australian State Nationals may serve in a Direct Jury Trial.

2. Foreigners and Australian Citizens (corporate entities):

- Foreigners and corporate Citizens are subject to and protected by the Law, but may not hold public office or qualify as electors.
- Foreigners and corporate Citizens may serve on Grand Juries but may not serve on a trial jury.

Upholding the law

Our **Jural Assemblies—National, Regional and Local—are entrusted** with the administration and upholding of the Law within their jurisdictions.

- **Peacekeeping Officers** are duly elected and appointed to **maintain order** and uphold these principles of Law.
- **All men and women share responsibility** to keep the peace and uphold the Law, fostering safe, collaborative caring communities.

Declaration

Let this stand as a **Lawful and binding declaration** of our commitment to the principles and tenets of Law on Terra Australis.

The Law on Terra Australis is the foundation of just and peaceful communities, free from corporate, statutory, and foreign interference. It reflects the collective will of the people and affirms that all who live upon or visit these lands are both protected by and bound to this Law.

This Law is hereby established by the authority of the Terra Australis General Assembly, as the expression of the collective will of the people.

May it preserve the peace and abundance of our lands and guide our lives for generations to come.
