



Declaration of Independence

Whereas it is the Natural and Inviolable Right of all people to live free and self-govern without coercion, oppression, or external interference;

And whereas the existing system of government, controlled by corporate interests and foreign powers, has failed in its duty to serve and protect the people—imposing unjust laws, perpetuating economic exploitation, and stripping us of our knowledge, history, health, sovereignty, and dignity;

We, the people of Terra Australis, in solemn recognition of our duty to present and future generations, hereby dissolve all political ties to foreign governing entities and their systems of legal administration.

Having publicly declared our peaceful assembly on 12 January 2024, we now establish a sovereign nation-state, upon the following principles:

- Peace and goodwill among all people,
- Truth, transparency, and integrity in governance,
- 'Love thy neighbour' and 'do no harm',
- Accountability for one's actions and their consequences,
- Protection of Natural Rights and property,
- Stewardship of the Earth, fostering harmony with the natural world,
- Responsible use of shared public assets, ensuring their preservation for future generations.

This declaration affirms our dominion over the land, air, and water, our resolve to establish safe, lawful communities, and our collective responsibility to participate in the governance and defence of our nation.

On 15 June 2023, during the International Assembly Coordinator meeting with Anna Maria Riezinger, the Terra Australis State Nationals were called to action with a clear directive: to swiftly issue a counterclaim securing the land and soil of Terra Australis. Anna emphasised the urgency of standing with the American State Nationals in presenting our unified claims before the Vatican Chancery Court on 20 June 2023.

On 19 June 2023, three status-corrected Terra Australis State Nationals, acting under the "Last Man Standing" principle, formally executed and autographed a lawful Notice and Counterclaim on behalf of all rightful heirs. This decisive action lawfully secured our nation's land and soil jurisdictions, countering the fraudulent claim that our lands had been vacated—an illusion perpetuated by the corporate fiction that all people had boarded the CITIZENship and were lost at sea.

We are assembled. We bring forth assembly-based self-governance—by the people, for the people.

I. Statement of Ideals

We hold these truths to be self-evident: all people are created equal, endowed with unalienable Natural Rights, an innate sense of right and wrong, and an inherent inclination toward doing what is right, bound only by the Land Law of Terra Australis. These rights exist beyond the reach of any earthly power and cannot be granted, revoked, or diminished by any authority.

Government exists solely to serve and protect the people. We reject all forms of tyranny, coercion, and exploitation. Legitimate power must first respect the sovereign individual and then the collective will of the people.

True freedom is not merely the absence of oppression but also the presence of knowledge, opportunity, dignity, and a spirit of mutual aid. We recognise our shared duty to uphold and protect these freedoms through active participation in our assemblies.

We are a people of peace, yet we stand resolute in defending these principles, ensuring that future generations inherit a world of freedom, harmony, and abundance.

II. List of harms

In the face of long-standing abuses of power, we find it necessary to enumerate the grievances that compel us to declare our independence and dissolve the bonds that have subjected us to the de facto governing structures. The following are some of the actions and policies that have betrayed the trust and void any presumed authority these corporations held over the people:

Healthcare and Pharmaceuticals Grievances

A well-functioning healthcare system should prioritise well-being, promote natural healing and a holistic approach.

- Profit over health: Pharmaceutical and insurance Financial interests too often take precedence.
- Over-medication: Prescription drugs are frequently overused, sometimes causing more harm than healing.
- Suppression of natural medicine: Proven natural remedies remain underutilised due to regulatory barriers.
- Medical negligence: Misdiagnoses and unnecessary procedures persist, leading to preventable harm.
- Vaccine injuries: Adverse effects are often downplayed, and mandates lack transparency.
- Neglect of mental health: Mental health challenges are exacerbated by systemic failings and policies.

Food and Agriculture

Agriculture should nourish both people and the land, but corporate and government control has distorted its purpose.

- Chemical reliance: Farmers may have used agricultural chemicals in good faith, but regulatory capture and corporate control have made safer alternatives financially nonviable.
- Live export: A critical industry for graziers and food security in importing nations; reforms to protect market access while ensuring higher-welfare standards.
- Corporate monopolies: Supermarkets and multinational agribusinesses suppress farm gate prices, inflate costs for consumers, and import foods available locally threatening food sovereignty.
- Genetically Modified Organisms (GMOs): Encouraging use of GMOs with known health risks.
- Factory farming practices: Industrialised agriculture prioritises profit leading to concerns over antibiotic overuse, animal cruelty and welfare, and food nutrition.
- Water and land control: Foreign and corporate ownership of essential water and agricultural assets threatens national food security and local farmers.
- Monoculture: Farming practices that strip the land of nutrients, making food less nutritious.
- Processed and synthetic foods: Promotion of ultra-processed foods high in chemicals, preservatives, and unhealthy oils.
- Water supply: Poisoning of drinking and bathing water with chemicals such as Fluoride and Chlorine.

Technology and Telecommunications Grievances

Technology should empower, not exploit. The current system prioritises control over progress.

- Information manipulation: Distortion of facts, spreading disinformation, and withholding truth.
- Surveillance and privacy violations: Mass data collection and tracking infringe on privacy.
- Censorship of free speech: Independent journalism and free speech are censored.

- The rapid deployment of 5G technology has occurred without safety data or full transparency on its long-term health and environmental impacts.
- Tech addiction: Exploiting vulnerabilities, fuelling addiction, anxiety, depression, and isolation.
- Manipulation via AI: AI and algorithms are used to influence public opinion and shape behaviour.

Finance and Banking

A stable financial system should serve the people, not exploit them. Use of military script creates slaves.

- Debt slavery: The financial system traps people in endless debt cycles.
- Trading whilst insolvent: since 20 April 2020

Energy and Utilities

Energy is abundant and affordable, yet access remains artificially restricted.

- Suppression of technologies: Viable free and very low cost energy technologies are hidden from the public.
- Overcharging for utilities: Sale of public utilities, overcharging and over taxing, limiting supply and reliability.
- Climate scam: Climate policies leveraged to push restrictive, expensive solutions that negatively benefit the environment and the people.

Government and Legal Systems

Government should protect and serve, not control, ignore and harm.

- Engaging in mercenary conflicts: Military actions serve foreign or corporate interests.
- Militarised Policy Enforcement: Weaponizing then encouraging the use of violence by policy enforcement.
- Ignoring the people's will: Lawful petitions and peaceful protests are disregarded.
- Failure to protect: Oppressive laws, regulations and violence remove freedom.
- Censorship: Restricting free speech and dissent through censorship, surveillance, and punitive measures.
- Corruption: Institutions created to control and strip assets while ignoring people's actual needs.
- Rule of Law: Neither government nor the legal system serve the people. Legal is not the same as Lawful.
- Betraying Public Trust: The government serves an unelected private elite, entering into treaties that support surveillance, medical tyranny, digital currency, social / carbon credit scores and other despotic policies.
- Taxation: Taxation without benefit to the people.

Environmental Harm

The land, water, and air must be protected.

- Geoengineering: Spraying of heavy metals, chemicals, technological and biological agents.
- Water sources: Polluting natural water sources with chemicals, industrial waste, and heavy metals.
- The Climate Change hoax: Policies framed around climate change are used to justify restrictions on freedoms and push private agendas, rather than genuine environmental stewardship.
- Green policy: Overregulation restricts farmers from caring for their land while allowing destructive corporate projects to proceed seemingly unchecked. Policies further reduce freedom.

Education

True education should foster wisdom, not compliance.

- Indoctrination: The education system prioritises conformity, obedience, and regurgitation.
- Student debt: Higher education has become a financial trap.

- Educational institutions promote an incomplete or misleading version of history and science, shaping narratives that serve political and economic agendas.
- Sexualisation of minors: Inappropriate topics are introduced under misleading pretences.

Transportation and Infrastructure

Roads, infrastructure, essential services belong to and should serve the people.

- Privatisation: Privatising essential transportation services and public assets.
- Planned obsolescence: Designing manufactured products to require frequent repairs or replacements.
- Neglect of infrastructure: Underfunding essential infrastructure (roads, bridges, public services).

Media and Entertainment

Media should inform and inspire, not deceive and manipulate.

- Propaganda and manipulation: Media pushing biased narratives that misinform or manipulate the public.
- Desensitisation: Family entertainment glorifying violence, sex, and unethical behaviour.
- Celebrity culture: Promoting shallow celebrity-driven culture to distract from social and political issues.

'Government' - unfit to rule

The above list of harms is indicative of the actions propagated by the current de facto government. Through these cumulative actions, any legitimate claim to govern in the best interests of the people is forfeited. The assemblies will provide a mechanism for stakeholders to come together and find real workable solutions themselves - every problem we face today has been legislated into existence.

iii. Lawful Justification

When a government ceases to serve the people and instead acts against them, it is the people's right and obligation to alter or abolish it and establish governance that protects their interests. This Declaration of Independence enshrines that duty.

By this Declaration, we restore Natural Law and prepare the way for real Law on the land and soil of Terra Australis, renouncing all unlawful claims of Maritime, Military, or other lower jurisdictions, including statutes, codes, and mandates that attempt to usurp our rights.

We affirm the principle of popular sovereignty. The sovereign people are the sole and rightful source of all political authority. We claim our nations sovereignty and establish governance subject to the collective will of the people.

This is lawful notice to all agents, officers, and contractors of corporations and de facto governments: Impersonating public officials is a crime. Your institutions, which should serve the people, have exceeded their lawful authority. You are subject to the will of those you claim to serve and will be held accountable for all harm you cause or enable.

IV. Final Declaration of Separation

By this Declaration, we, the State Nationals on Terra Australis, claim our dominion over our land, laws, and governance, formally and irrevocably separating ourselves from the oppressive structures of the past. We renounce all allegiance to de facto governing bodies and reject all unlawful claims.

The people are not bound by treaties, agreements, or arrangements made by de facto government entities, as such agreements hold no lawful authority.

Terra Australis stands independent, governed by the assembled sovereign people exercising the inherent right to self-determination. No external force has the right to dictate our lives or control our destinies.

We declare our peaceful independence with the support and acknowledgement of the de jure government of The United States of America, the fifty States assembled, and the people assembled in England, Eire, Northern Ireland, Terre Italiche, Portugal, Terra Canada, Jamaica, Romania, South Africa, Spain, and Estonia. These nations stand as witnesses to the creation of a new nation, Terra Australis, affirming our rightful place among the free peoples of the Earth.

Affirmation

We, the undersigned, as living, reconveyed suveran nationals on the Land and Soil of Terra Australis, do hereby affirm and proclaim our Nation's Independence in behalf of all who call these lands home.

By this declaration, we stablish lawful jurisdiction on the Land and Soil of Terra Australis, rejecting all foreign claims, corporate authority, and unlawful impositions, standing as free men and women, united, unwavering, and guided by truth.

In witness whereof, we affix our autographs—consciously with free will—affirming the collective will of the people of Terra Australis.

This declaration is affirmed, sealed, and delivered on this day, _____, in the year of our Lord 2025, by the free men and women of Terra Australis.
