The law is the definition of the people's power and is common sense. The law protects living people from harm, loss, and fraud. Statutes, however, are the enactments of the legislature that apply to publicly registered legal entities as franchises of the public state. 1. For those who want to activate step one.

2. For those looking for the correct way in which to deal with the Courts.

The American State Assemblies, via Judge Anna, have over 5000 articles. Only in America might the public defender's letter work, but not here in Sunny Down Syndrome, AUSTRALIA, and today we have firsthand evidence of this being a fact. So what does that actually mean? What is the difference between a magistrate's court and the supreme court? Where do you go from here?

What makes all of this worse is that all Australians are in probate since the English Wills Act 1837, but where do we see this connexion with the District of Columbia? a topic we'll be discussing in detail. In recent times we have discovered, in their own words, the magistrate courts have admitted they are, in fact, UNIDROIT Article 1, *de facto* inferior courts, and that now raises the stakes, where we all have absolutely no option but to become state nationals. This and more we unravel in our seven-hour, all-day workshop.

Understanding at least some of the fundamentals of contract law is vital, and so it is up to you to continue to research and never to follow others blindly. It is no wonder the banks do not want you to open up this type of account. The bank will try its very best to reject your application.

The bad conduct of all banks is simply endless, and they must always be watched closely. Remember, your legal fiction is very much like your dark shadow that will continue to follow you around all of your life. Comprehending that you can never fight your shadow should help you better embrace their legal system without fear. 
